Procedure for Defining University Units

Definitions:

University Unit refers to an individual unit or group of consolidated units made up of a school or college and any departments or divisions which are a subdivision of a college or school; centers, facilities, labs, libraries, or program within a college or school, or as an independent entity; offices; associations; and administrative units

Mission Critical is any factor (component, equipment, personnel, process, procedure, software, etc.) that is essential to business operations.

Reputational Harm often called reputation risk, is the potential loss to financial capital, social capital and/or market share resulting from damages to a firm's reputation.

Significant Harm is the permanent loss of revenue to the organization in excess of \$1M.

Inclusion Criteria

The Vice President for Finance and Administration and the University Provost, or other University executive management they delegate, will identify University units that provide business functions that if disrupted could impede the university's ability to meet its mission and/or strategic goals, could have a major financial or reputational impact, or could result in significant regulatory or contractual non-compliance, required to participate in the vulnerability management program, maintain a Business Impact Analysis, Disaster Recovery Plan and Risk Assessment on a triennial basis.

University units identified to maintain a Disaster Recovery Plan will exercise the plan on an annual basis, document lessons learned, and develop remediation steps to address plan weaknesses. Business Impact Analyses, Disaster Recovery Plans, Disaster Recovery Tests, Lessons Learned and Risk Assessments will be submitted to the Chief Information Security Officer in the Information Security and Privacy Office for review by the end of the calendar year as referenced in the Three Year Cycle schedule.
